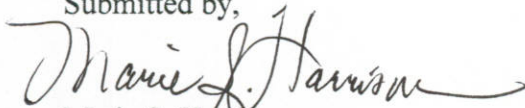
SCSBA Regional Advocacy Meeting on Wednesday, September 25, 2019, at Lexington Four Early Childhood Center in Swansea, SC.
